





2020 Virtual Leadership Seminar

Legislature Appropriates Remaining Federal COVID Funds

The legislature was back in session this week to appropriate remaining federal COVID funds. The General Assembly had hoped for additional federal flexibility on the use of the remaining funds, especially the authority to use those funds for revenue replacement. However, Congress has not enacted any additional COVID legislation. Therefore, because these funds must be spent by December 30, 2020, the General Assembly returned to session to designate appropriations for various COVID-related projects. Since the General Assembly adjourned sine die, the Governor has 30 days to sign or veto the bill. If the Governor does not enact within 30 days, the bill becomes law. Following are the community college appropriations and provisions:

System Provisions

- PPE -- \$5 million to the Community College System Office for allocation to colleges to purchase PPE and testing.
- Healthcare & First Responder Equipment -- \$5 million to the Community College System Office for allocation for equipment costs for healthcare workforce and first responder programs necessary to the State's COVID-19 response.
- Purchasing Flexibility Allows community colleges (and other agencies) to obtain in the open market necessary supplies, equipment, materials, printing, or services to address the COVID-19 pandemic, including purchases that exceed purchasing benchmarks, without the authorization or approval of the Department of Administration. Also requires a report on COVID-19 expenditures to be made as a matter of record, and if the expenditure exceeds the benchmark, the report must also be made to the Division of Purchasing and Contract.

Individual Community Colleges

- CVCC & Gaston College: \$14.3 million for the PPE Initiative partnership between the CVCC-Manufacturing Solutions Center and Gaston College-Textile Tech Center, Conover, Gaston County, and the private sector to create a launch pad for prototyping and testing reusable PPE products for entrepreneurs and existing manufacturers. The Office of State Budget & Management (OSBM) will allocate the funds as follows:
 - \$9,000,000 to Conover to be allocated for:
 - \$7,250,000 to construct a facility to house testing labs, rapid prototyping, and a textile sourcing library.
 - \$1,250,000 for a clean-room upfit at the CVCC-MSC.
 - \$500,000 for equipment, materials, and logistics for a rapid prototyping pilot line to create product and train a workforce for US PPE manufacturers.
 - \$5,300,000 to Gaston County to construct an Incubator and Extrusion Center for Advanced Fibers at the Gaston College Textile Tech Center.
- **Cleveland CC: \$1 million** for PPE, equipment, and training to be allocated by the Community College System Office.
- **Sampson CC: \$250,000** to address impacts related to COVID-19 to be allocated by the Department of Commerce.

These funds are from the federal Coronavirus Relief Fund (CRF), and therefore, must be spent by December 30, 2020, and in accordance with the purposes outlined in HB 1105 (if enacted) as well as compliance with federal guidance on the permissible expenditures of CRF funds.

ACCT Rural Project

Over the last couple of months, North Carolina Community College Presidents and Trustees from rural communities have been meeting (via Zoom) with representatives of the national trustees association to discuss specific issues impacting their colleges. Beaufort Community College President Dr. David Loope and Board Chair Rev. Bob Cayton have taken the lead to invite and facilitate the Zoom meetings on behalf of the NCACCT.

As reported earlier, the ACCT received a grant from the Gates Foundation to study issues impacting rural colleges in five different states, and North Carolina was one of the states chosen. This project will engage rural community college presidents, trustees, and other stakeholders to gather new information about the challenges faced by these colleges and to develop potential state and federal policy solutions to support their long-

term viability. The ACCT will develop and release a report in the spring of 2021.

The State Board of Community Colleges has begun the search for president of the NC Community College System. The board's President Search Committee finalized a position profile for the system presidency after receiving input from the NCACCT and the NCACCP.

According to the profile, the next president should have a passion for the mission and philosophy of the NC Community College System. The job description calls for an experienced leader with a commitment to public higher education, open access, affordability and academic excellence.

The next leader will succeed Peter Hans, who was recently named president of the University of North Carolina System. Bill Carver, former president of Nash Community College, became interim president of the community college system on August 1. Lingle will replace Stephen Rosenburgh of Mecklenburg County, who resigned after being appointed to the Board of Transportation. Sen. Harry Brown, R-Onslow, spoke highly of Lingle saying he was "one of the best community college presidents in the state for many, many years."
